

## Privacy Policy

The Dharma Charitable Foundation is committed to protecting the privacy of donors and users.

Accordingly, we have compiled this Privacy Policy, which

concerning the collection, use, publication, transfer and storage of personal data. Our activities is in accordance with all relevant European Union legislation and the laws of the Republic of Estonia.

Controller The controller of the personal data mentioned in the Privacy Notice is SA Dharma (registry code 90006518, address Rotermanni 8, Tallinn. Website [www.dharma.ee](http://www.dharma.ee)).

## Principles

The Dharma Charitable Foundation follows the following principles in the processing of personal data:

- Principles of legality, fairness and transparency - processing is lawful, fair and transparent to the data subject;
- Purpose limitation principle - personal data is collected in a well-defined and clearly defined way and for legitimate purposes and are not further processed in a way that is contrary to the objectives of the
- The principle of collecting as little data as possible - personal data are relevant, relevant and limited to what is necessary for the purpose for which they are processed;
- Principle of accuracy - personal data are accurate and, where necessary, kept up to date and that they are taken all reasonable steps to ensure that personal data are incorrect for the purpose of the processing deleted or rectified immediately;
- Retention limitation principle - personal data are stored in a form that allows identify data subjects only for as long as is necessary for the purpose for which they are provided personal data are processed;
- Principle of reliability and confidentiality - personal data are processed in a way that ensures appropriate security of personal data, including protection against unauthorized or illegal processing accidental loss, destruction or damage, using appropriate technical or organizational measures.

## Collection and use of personal data

Personal data is data collected through donations. The processing of personal data takes place under contract

and to ensure compliance. The collection of personal data can take place in the following ways:

When making a donation in our donation environment, personal contact information storage. The required personal information may include name, e-mail address and personal identification code.

The purposes of the processing of personal data are:

- With the help of collected personal data, we can manage and enable donations.
- The personal identification code is used to refund income tax to the donor.

Protection of personal data

The Dharma Charitable Foundation takes all precautionary measures (including administrative, technical and

physical measures) to protect the customer's personal data. Access to edit data and only authorized persons have the right to do so.

Security

All personal data of the client that has become known in the course of making donations in the donation environment

treated as confidential information. An encrypted data channel with banks ensures the purchase security of the performer's personal data and bank details.

Third parties and processors

As the administrator of the donation environment, the Charity Foundation Dharma has access to all user data,

but uses them only to compile overview statistics (eg monitoring donation volumes by month and years) and not for the analysis of individual donations and donors. User data is protected security and confidentiality rules and shall not be disclosed to third parties.

Retention of personal data

The charity Dharma stores personal data in a form that allows data subjects to be identified only for as long as is necessary for the purpose for which the personal data are processed, with the exception of

unless required by law to provide for different time limits for the storage of personal data.

Rights of the data subject

All donors and users (data subjects) have the following rights:

- The data subject has the right to delete personal data.
- The data subject has the right to make inquiries about personal data concerning him or her.
- The data subject has the right to restrict the processing of personal data.
- The data subject has the right to file a complaint regarding the processing of personal data
